THE DEVELOPMENTAL DAY CENTER PROVIDES AN INCLUSIVE CENTER-BASED PROGRAM FOR CHILDREN 18 MONTHS TO SIX YEARS OF AGE WITH, OR AT RISK FOR, DEVELOPMENTAL DISABILITIES AND FOR CHILDREN WHO ARE TYPICALLY DEVELOPING. IN CY 2015, WE SERVED 100 CHILDREN. IN CY 2015, 82% OF ALL CHILDREN DEMONSTRATED EXPECTED LEVELS OF COGNITIVE, LANGUAGE AND DEVELOPMENTAL SKILLS. IN FALL 2015, 96% OF OUR "GRADUATING" CHILDREN WITH A DISABILITY ENTERED KINDERGARTEN ON THE STANDARD COURSE OF STUDY.

THE CHILD MENTAL HEALTH INITIATIVE PROVIDES COMPREHENSIVE SERVICES TO CHILDREN AGES BIRTH TO EIGHT YEARS WHO HAVE DEMONSTRATED SERIOUS SOCIAL, EMOTIONAL, BEHAVIORAL, AND/OR MENTAL HEALTH CONCERNS THAT JEOPARDIZE THEIR CHILD CARE, FAMILY LIFE, AND FUTURE GROWTH AND DEVELOPMENT, AND COUNSELING TO THEIR FAMILIES.
